DECREE

of the Ministry of Culture of the Slovak Republic

of 13 June 2014

on the Film Project

Pursuant to Section 22a(2) of Act No. 516/2008 Coll. on the Audiovisual Fund and on the Amendment of Certain Acts as amended by Act No. 374/2013 Coll. (hereinafter referred to as "the Act"), the Ministry of Culture of the Slovak Republic hereby stipulates as follows:

Section 1

Minimum Length of a Film Project

Pursuant to Section 22(1) of the Act, funds supporting the audiovisual industry may be provided for the making of a film project which:

- a) consists of one, two or three individual cinematographic works¹), where each work is at least 70 minutes in length; or
- b) is an audiovisual work primarily intended for television broadcasting and is
- 1. an individual audiovisual work at least 40 minutes in length; or
- 2. a multi-episode audiovisual work consisting of not more than 13 episodes and each episode is at least 40 minutes in length.

Section 2

Cultural Test Criteria and Cultural Test Sample Form

- (1) Criteria for the cultural test are divided into
- a) Basic;
- b) Cultural;
- c) Realisation.
 - (2) A film project which may be provided with realisation funds for the support of audiovisual industry under Section 22a(1) of the Act shall be deemed to meet the cultural test criteria if the audiovisual work meets the basic criterion and achieves at least 24 points of the total number of points in the cultural test; of these, at least 9 points are to be obtained for cultural criteria.

(3) The cultural test criteria are specified in the cultural test sample form, in the Annex to this Act.

Section 3

Minimum Amount of Eligible Expenditures

The minimum amount of eligible expenditures paid in relation to the creation of a film project under Section 22a(1) of the Act is EUR 2,000,000; this minimum amount is not to exceed 50% of the total budget for the production of the film project.

Section 4

This Decree comes into force on 1 July 2014.

Explanations:

- 1. For criteria 1.1 and 1.2, a maximum of 1 point is to be awarded for each criterion.
- 2. For criteria 1.3 through to 1.8 and 1.13, a maximum of 0.5 point is to be awarded for each criterion.
- 3. For criterion 1.14, 0.1 point is to be awarded for every profession; however not more than 0.5 point.
- 4. For criterion 2, 1 point is to be awarded for every state; however not more than 4 points.
- 5. For criterion 3, points are to be awarded as follows:
- a) 1 point, if the number of filming days within the territory of the Slovak Republic is at least 10% of the total number of filming days;
- b) 2 points, if the number of filming days within the territory of the Slovak Republic is at least 20% of the total number of filming days;
- c) 3 points, if the number of filming days within the territory of the Slovak Republic is at least 30% of the total number of filming days;
- d) 4 points, if the number of filming days within the territory of the Slovak Republic is at least 40% of the total number of filming days.
 - 6. For criterion 5, points are to be awarded as follows:
- a) 1 point, if the number of post-production days within the territory of the Slovak Republic is at least 10% of the total number of post-production days;
- b) 2 points, if the number of post-production days within the territory of the Slovak Republic is at least 20% of the total number of post-production days;
- c) 3 points, if the number of post-production days within the territory of the Slovak Republic is at least 30% of the total number of post-production days;
- d) 4 points, if the number of post-production days within the territory of the Slovak Republic is at least 40% of the total number of post-production days.
